## TRICK OR TREATING SAFETY TIPS

#### Costume Safety

- **Visibility**: Wear light-colored clothing or add reflective tape to costumes and treat bags to help drivers spot you.
- Vision: Choose face paint or makeup over masks to avoid obstructed vision.
- **Fit**: Ensure costumes fit well to prevent trips and falls.
- **Flame-Resistant**: Look for "flame resistant" labels on costumes and accessories, and avoid long, trailing fabrics.

#### Walking Safely

- Adult Supervision: Young children should always trick-or-treat with a parent or trusted adult.
- **Stay in Groups**: Older children trick-or-treating without adult supervision should stay together in a group.
- Use Crosswalks: Always cross streets at corners using traffic signals and crosswalks.
- Stay on Sidewalks: Walk on sidewalks and paths, not in the street.

#### **Visiting Homes**

- Look for Lights: Only approach houses with porch lights on.
- Stay at the Door: Accept treats only at the front door; never go inside a stranger's house or car.
- Animals: Be cautious around unfamiliar animals.

#### **Treat Safety**

- Inspect Candy: Parents should check all candy before children eat it.
- **Discard Unsafe Treats**: Throw away unwrapped, homemade, or any suspicious-looking treats.

### MINUTES OF THE BOARD OF DIRECTORS THE HOMES, INC. September 15, 2025

The regular monthly meeting of the Board of Directors of The Homes, Inc. was called to order at 5:30 p.m. on September 15, 2025.

Present were: Elaine Hines, Ray Olson, Joe Merrick and Charles Sawyer, Board Members; Elizabeth Bothwell, Manager; Greg Goheen, Attorney; and Karen Brokesh, Transcriber. Oscar Solis was absent.

Eight stockholders and residents attended the meeting.

It was announced that the work order report for August has been posted.

Minutes of the regular meeting of August 18, 2025 and the executive session had previously been distributed to all board members. Elaine Hines moved to approve the minutes as submitted. Seconded by Joe Merrick. Carried unanimously.

Treasurer Olson reported that he has reviewed the financial statement for the month of July 2025 and found it to be in good order. Ray Olson moved to approve the financial reports. Seconded by Charles Sawyer. Carried unanimously.

The stockholder change request for board approval was submitted by Marcia Merrick, 3125 N. 9<sup>th</sup> Street, to install a chain link fence.

Charles Sawyer moved to approve the stockholder change requests. Seconded by Ray Olson. Carried unanimously.

After being informed that the stock transfers were in order, it was moved by Charles Sawyer and seconded by Ray Olson that the Corporation waive its option to purchase the shares of stock and approve transfer of same. Carried unanimously. The manager was reminded that all original signed stock certificates must be stored with the credit union if the stockholder has an outstanding loan.

Old Business to be Discussed: Stockholder Devra Harrison provided an update on the road construction in the area. The Unified Government supplied a letter to send out to residents about the changes on Viewcrest and The Homes will mail them out. The Unified Government's Street Department is going to stripe the new diagonal parking but The homes will have to purchase the paint. The expenses that The Homes is incurring will be reflected int eh challenge of the real estate taxes. Manager is hopeful the changes will be made before winter. New Business to be Discussed: Manager would like to create a separate nonprofit business entity specifically for the betterment of The Homes and its residents that would be similar to Neighborhood Watch. The nonprofit would be able to obtain financial grants for playground equipment, landscaping, animal welfare, walking paths in the parks and anything that would benefit The Homes. The nonprofit would have its own board of directors, by-laws, accounting system and serve the residents of The Homes. Strict guidelines would keep the business entity separate from The Homes. Manager will have more information at next month's meeting. Greg Goheen commented that The Homes looked into the formation of a similar entity about ten years ago and documents were drafted at that time that may be able to be used. Recently, there have been stockholders who have not been able to locate other stockholders on their stock certificates. Manager distributed information that has been gathered to help stockholders legally remove another stockholder from their share of stock. Parents in The Homes are reminded to make sure that their children understand that they need to be respectful of other residents' property. Recently, there have been issues with children entering units without permission and damaging property. Parents will be held responsible for their children's actions. A double chain has been put up to block access to the dumpster when the office is closed. Residents have been overfilling the dumpster and leaving a mess that maintenance has to clean up. As a reminder, there are cameras around the office and residents caught dumping after hours will be fined. A groundskeeper has been hired and started last week. Fall inspections have begun. Comments from Directors and Attorney: None. Comments from Stockholders: The stockholder at 108 Viewcrest asked about a piece of personal property that was stored in The Homes'

The stockholder at 12 Summitteest commented on the need for quiet hours in the community.

#### **FURNACE INSPECTIONS HAVE BEGUN**

We have startted inspections at the back of the community and working our way forward.

5. Where can you go to paint pumpkins?

#### **Greener Lawns and Cleaner Ponds**

We all want what's best for our plants; fertilizing them is a common way to help them. However, using too much fertilizer can cause problems, not just for your yard. When fertilizer is overused, rainstorms and periodic watering can result in large amounts of nutrients being washed off into our storm sewers and, eventually, into our local waterways. Once there, it can cause anything from the overgrowth of aquatic plants to large-scale fish kills.

How much fertilizer is too much fertilizer? Luckily, this question, and others, can be answered with a simple soil test, provided by the Unified Government for residents of Kansas City, Kansas, for free! Your soil test can help you answer four critical questions:

- 1. What nutrients does my soil need?
- 2. What type of fertilizer should I use?
- 3. How much fertilizer should I use?
- 4. How often should I fertilize?

By taking advantage of your free-soil test, you will be more informed about how to take care of your lawn better, and you will also be protecting our local waterways in the process! Keep your lawn green and our waterways clean!

## How to Take a Good Soil Sample

Follow these steps to get a representative soil sample for testing.

- 1. Using a clean shovel or garden trowel, dig down to a depth of:
  - 4 inches for lawns or pastures
  - 6 inches for vegetables, flowers, and small fruits (blackberries, raspberries, strawberries)
- 2. Collect soil from 4 5 locations for testing the area. Each sample should be about 1 cup in size.
- 3. Mix soil samples together in a clean bowl or container. Remove all plant material or debris, like roots, sticks, leaves, worms, grubs, and bugs.
- 4. Let the soil dry out in the open air. The soil should be dry, but do not use heat to dry the sample.
- 5. Place two cups of the dry, mixed soil in a resealable, quart-size plastic bag; write your name and phone number on the bag.
- 6. Fill out your soil test form on the K-State Soil Testing webpage https://www.wyandotte.k-state.edu/program\_areas/lawn-garden/soil\_testing/ (If you are unable to print out the form then come to the Homes office and we can print one for you.)
- 7. Bring the soil sample to the Wyandotte County K-State Extension Office at 1216 N. 79<sup>th</sup> Street, Kansas City, KS 66112, during the weekday (Monday to Friday) between 8:00 AM and 4:30 PM.
- 8. You will receive the soil test results by mail in 2-3 weeks.

## HELPFUL HINTS ABOUT LIVING IN THE HOMES

KEEP FURNACE AND WATER HEATER AREAS CLEAN. Having too many clothes, boxes, or general clutter in your utility area can be a fire hazard. Please keep yourself and your neighbors safe and keep your utility areas clean. DO NOT PILE CLOTHES OR OTHER ITEMS ON TOP OF THE WATER HEATER OR FLU AREA. CHANGE YOUR FURNACE FILTER ONCE A MONTH. FILTERS ARE FREE AT THE OFFICE.

PLUMBING: DO NOT FLUSH FLUSHABLE WIPES. The pipes in our homes are over 70 years old. They do not have the capacity to wash away any other material. Do not flush baby wipes, feminine hygiene products, diapers, paper towels, Q tips, etc. The sink and tub drains are only for water disposal. Do not force items down the drains. If maintenance finds these items consistently causing a back-up in your pipes you may be charged for the repair.

**LITTERING.** Think twice about throwing your trash out your car window or into someone's yard. First, it's rude and selfish. Someone will have to pick it up and most of the time it is the maintenance staff. This takes time and money away from other resident's needs. Second, it is against the law. Littering is a Class C violation that is punishable by a fine up to a \$2500.00. If you are witnessed littering the police will be called and you will be charged, by The Homes, for the time it takes to pick it up and dispose of it.

**PARKING:** The Homes does not have assigned parking. Please be considerate of your neighbors and their parking needs. Try not to park in a spot that is normally used by your neighbor. If you have guest, have them park in the overflow lots. If you have vehicles that you do not drive, park it in an overflow lot. **NEVER PARK IN YARDS OR COMMON GROUND. IT COULD RESULT IN A FINE OF \$250.00** 

**NOISE.** Please be mindful of the level of noise you create. It is our responsibility to keep the sound we make to a reasonable level, so we are not disturbing our neighbors. Sometimes, simply communicating with your neighbors and working out an understanding can resolve this and many other problems.

YARDS & PORCHES: Please take the time to clean up/organize your yard and porch. The size of our porches does not allow for you to keep many items on them before they start to look cluttered and messy. If you do not have a shed an affordable idea to store your items in are deck and patio boxes. They range in cost from \$30 to \$100 and can be purchased on-line or at your local discount store. Items that should not be on your porch: appliances, boxes, buckets, mops, paint containers or any other "non outdoor" items. The office offers free paint for the porches.

**SPEEDING.** The speed limit in The Homes, Inc. is 20 mph. It only takes a few seconds for a distracted child to dart out in the road. Please be aware and safe while driving.

**AUTOMOBILE REPAIR**. It is against the rules to work on your vehicle in The Homes. If your vehicle needs repair, then you will have to go out of the neighborhood or take your vehicle to a mechanic. Unless you are changing a flat tire you should never put your vehicle on a jack in the Homes. **IT COULD RESULT IN A FINE OF \$250.00** 

**TRASH**. Do not put your trash to the curb before 4:30 pm the day before pickup. Do not put your trash in your neighbor's trash bins.
